DIRECTIONS: TAKE INTERSTATE 87 TO EXIT 26. Coming from the south, turn left onto Valley Farm Road for 1/4 mile, turn right (North) onto St Rt9 and go 1/2 mile, turn left onto Stone Bridge Rd and go 2 1/2 miles to the end. Coming from the north, turn right onto Stone Bridge Rd and go 2 miles to the end. There are several parking lots at the attraction, the event will start in the lower parking lot to the right of the turn a round at the caves.
